Graft is a big problem in Uttarakhand: former CM

In a video that went viral on social media, former Uttarakhand Chief Minister and MP Tirath Singh Rawat is heard saying that "commission khori" (corruption) is the biggest problem in the hill State. The video is causing a major embarrassment to the BJP government.

During an interview to a national media channel, Mr. Rawat said that after the creation of Uttarakhand from Uttar Pradesh in 2000, the issue of 'corruption' should have come to zero, "but the practice of commission khori continued and we began with 20% here in Uttarakhand. It is ironv".

The former Chief Minister said that he would not blame any one person for the "corruption" as it was a "mentality" which would not change unless one started considering the State as his/her family.

While the Congress attacked the government on Mr. Rawat's statement, the BJP's media in-charge, Manvir Singh Chauhan, said that he had his own point of view.

Across Gujarat, dissidents give a tough time to BJP and Congress

he ruling Bharatiya Janata Party (BJP) and Opposition Congress, whose leaders are engaged in candidate selection in the State, are facing dissidents in several constituencies. While the ruling party is yet to name 16 candidates for crucial seats in Ahmedabad and north Gujarat, the Opposition party has not named more than 30 candidates for central and north Gujarat regions.

The BJP faces dissidence and rebellion by party cadre in around a dozen seats in south Gujarat and Saurashtra.

On Monday, more than 1,000 supporters of former MLA Dhawal Zala arrived at the BJP State headquarters in Gandhinagar, demanding that he be declared the candidate for the Bayad seat in north Gujarat. The party has selected former MLA Bhikhiben for the seat.

Similarly, supporters of former Minister Ranchhod Rabari held a show of

strength in Patan, demanding nomination for him after the local media reported that the former Minister was unlikely to be fielded by the party. The BJP is yet to name the candidate for Patan.

The Congress, on its part, had angry workers rush to the party headquarters in the city after it released the candidate list late Sunday night. The party workers demanded changes in several constituencies such as Vatva in Ahmedabad city.

On Sunday, the two parties were forced to change the candidates for the Vadhwan and Botad seats. The BJP had first announced Jignaben Pandya for the Vadhwan seat in

Legislators resign

Elections to the 182member Gujarat Assembly will be held in two phases on December 1 and 5. The counting of votes will be taken up on December 8.

For the first phase, 89 seats of Saurashtra and south Gujarat will go to the polls on December 1. Monday was the last day for filing of nominations.

For the remaining 93 seats in the State, the polling will be held on December 5. November 17 is the last day to file nomination papers.

Congress appoints big team of observers for Gujarat election

Barely two weeks before the first phase of voting in Gujarat, the Congress on Monday announced a massive team of poll observers to supervise the party's

campaign in the State. The All India Congress Committee (AICC) has divided the State into different zones and appointed an observer for each of the 26 Lok Sabha constituen-

cies in the State. A statement from AICC general secretary (organisation) K.C. Venugopal stated that Mukul Wasnik will be the party observer for the south zone headquartered in Surat, while Mohan Prakash will oversee the polls in the Saurashtra zone, headquartered at

Rajkot. Former Maharashtra Chief Minister Prithviraj Chavan will be stationed at Baroda to oversee the campaign in the central region. B.K. Hariprasad and K.H. Muniyappa will look after the north zone, with Ahmedabad as the headquarters.

The AICC appointed Shakeel Ahmed Khan, Ra-

jesh Lilothia and Jai Kishan as general observers, while Shivaji Rao Moge is an observer for south Gujarat. Kantilal Bhuria has been assigned central Gujarat.

The appointment of observers comes amid criticism that the Congress is hardly visible in its Gujarat campaign when compared to newcomer Aam Admi Party (AAP) that has run an aggressive campaign to take on the 27-year-old rule of the Bharatiya Janata Party (BJP) in the State.

Sources in the Congress said former party chief Rahul Gandhi is likely to campaign. His extensive campaigning in the 2017 Assembly election helped the party win 77 seats. Plans are still being worked out on whether Mr. Gandhi will attend physical rallies on the rest days of the Bharat Jodo Yatra or address digital rallies.

It's a tough pitch for Riva Jadeja in Gujarat's Jamnagar

It is not a straight pitch for cricketer Ravindra Jadeja's wife Riva Jadeja, who is taking guard in electoral politics at Jamnagar North as the BJP candidate in the Assembly election in Guiarat. She is less than three years old in the party but has aldisruption, with the BJP choosing her over the incumbent legislator, Dharmendrasinh M. Jadeja, better known as Hakubha. The MLA was dropped after the High Court declined to withdraw criminal proceedings against him in a rioting case. Hakubha has represented the seat twice. In the 2012 Assembly election, he won it on a Congress ticket and in 2017 as a BJP candidate. When The Hindu met Ms. Jadeja on Sunday, her campaign had not yet formally started. Sipping tea from tiny paper cups and between several rounds of photographs, things are settled. The entire programme is over in around 40 minutes and she has another six destinations to reach before she can call it a day.

Riva Solanki or Riva-ba (*Ba* is an appellation used in Gujarati mostly for older women or out of respect) and Mr. Jadeja married in 2016; the couple has a fiveyear-old daughter.

Though this is Ms. Jadeja's maiden election, she is not alien to politics. Her uncle Hari Singh Solanki has been a senior Congress leader at Rajkot; now he has switched over to the BJP.

Her sister-in-law is with the Congress. She herself

had a stint in Karni Sena, an organisation that often hits headlines for its protests against Hindi films.

"Since the ninth standard, I wanted to be an IAS officer to serve the country and society. But before I could really give it a shot, I got married and had my daughter. I had begun to feel that my own goals and aspirations were being left behind," she recalls.

She gives credit to her husband for inspiring her to join politics and the turning point, she says, was the couple's meeting with Prime Minister Narendra Modi in November 2018.

Ms. Jadeja dismisses the challenge posed by the Aam Aadmi Party. "They are outsiders. Saying a few things on social media or speaking about Gujarat in rallies outside the State, do not mean a thing. A third political force has never succeeded in Gujarat and will not," she adds.

Though she may wave off the AAP, for now, Ms. Jadeja has a bigger problem on hand of keeping dissidence at bay.

According to sources, the BJP has appointed Hakubha in charge of the three seats in Jamnagar. "The BJP is a cadre-based party and we work as a cohesive unit and uniformly follow the high command's orders," she says.

A view also shared by a band of BJP workers organising these "meet and greet" events. "We only see kamal (Lotus). Whoever is holding our symbol, we stand behind them," Babu Bhai Chavda, BJP leader said.
