A jury on Tuesday found six people guilty of terrorist murder for extremist attacks in 2016 that killed 32 people, Belgium's worst peacetime violence, according to Belgian media. # Protests roil Israel over new law, doctors keep off work

A day after govt. approved law weakening Supreme Court, at least 40 held for staging protests; civil rights groups file petitions in the top court demanding that the decision be overturned

housands of Israeli doctors walked out of work, labour leaders threatened a general strike and senior justices rushed home from a trip abroad on Tuesday, a day after the government approved a law weakening the country's Supreme Court that critics say will erode the system of checks and balances.

Four leading Israeli newspapers covered their front pages in black ink - an ominous image paid for by an alliance of high-tech companies. The only words on the pages were in a line at the bottom: "A black day for Israeli democracy".

Monday's vote – on the first of a series of measures that make up Prime Minis-

ter Benjamin Netanyahu's divisive judicial overhaul – reverberated across the country. It came despite seven months of fierce popular resistance.

Hundreds of thousands of people fanned out in Tel Aviv overnight, burning tyres, setting off fireworks and waving national flags. In Jerusalem, mounted police and water cannons spraying foul-smelling liquid cleared protesters from a main highway. At least 40 people were arrested by police in protests around the country.

Videos showed police officers dragging protesters by the hair and neck, beating people until they bled and violently pushing them back with batons. At least 10 officers were assaulted, the police said.

# Israeli military kills 3 alleged Palestinian gunmen

The Israeli military said it shot and killed three alleged Palestinian gunmen in the northern occupied West Bank on Tuesday, the latest bloodshed in one of the most violent stretches of the Israeli-Palestinian conflict in years.

Israeli security forces said they opened fire at Palestinian militants who had shot at them from a car in the West Bank city of Nablus, the territory's commercial capital and a major focus of the Israeli military's recently stepped-up raids.

In the hilly neighborhood of al-Tur shortly after the shooting, Israeli forces inspected a shattered black Skoda (car) surrounded by spent bullet casings.

The Israeli military said it confiscated three M-16 rifles and other equipment from the alleged attackers'

# of contempt, says lawyer

Pakistan's election oversight body said on Tuesday it would indict the country's former Prime Minister Imran Khan next week on charges of publicly insulting its officials last year. Mr. Khan appeared be-

fore a special tribunal of the Election Commission of Pakistan along with his lawyers amid tight security in the capital, Islamabad. After a brief hearing,

Shoaib Shaheen, one of Mr. Khan's lawyers, said the tribunal decided to charge the former premier with contempt on August 2. Mr. Khan is accused of calling the head of the electoral body, Sikandar Sultan Rajaa, and several of its officials "personal servants" to Prime Minister Shehbaz Sharif at several gatherings. Mr. Sharif replaced Mr. Khan in April 2022 after he was ousted from power in a no-confidence vote in Parliament.



Imran to face fresh charges

Mr. Khan had been avoiding appearances before the tribunal for the past several months, saying the electoral body doesn't have the authority charge him with contempt.

On Monday, the election oversight body ordered Mr. Khan's arrest after he repeatedly failed to show up before its tribunal to face contempt charges over his public outbursts against election commission officials.

Mr. Khan was not arrested and showed up of his own volition on Tuesday

before the tribunal.

Since his ouster, Mr. Khan has been slapped with more than 150 legal cases, including several on charges of corruption, "terrorism" and inciting people to violence over deadly protests in May that saw his followers attack government and military across the property country.

Mr. Khan also appeared before the country's Federal Investigation Agency on Tuesday to face charges of exposing a secret document. Last week, Mr. Sharif's government said it would charge Mr. Khan for "exposing an official secret document" last year when he waved a confidential diplomatic letter at a rally, describing it as "proof" that he was threatened and claiming his ouster was a conspiracy.

Mr. Khan claims his ouster was part of a U.S. plot, a claim which has been denied by Mr. Sharif and Washington.

# **Uncertainty remains**; Sanchez is interim PM

Pedro Sanchez was on Tuesday formally named caretaker Prime Minister of an interim government that will remain in place until Spain resolves the political uncertainty that emerged from Sunday's inconclusive elections.

Although Alberto Nunez Feijoo's right-wing Popular Party (PP) won the vote, it fell short of a governing majority, handing Mr. Sanchez's Socialists a lifeline as they have more options to create alliances with smaller parties.

"I hereby declare the dismissal of Pedro Sanchez as head of government



who will remain in office until a new Prime Minister takes office," King Felipe VI said in the official State

If the political deadlock is not resolved in the coming months, Spain will likely have to hold a repeat election.

# China, Russia to send delegates to North Korea

Both Russia and China are sending government delegations to North Korea this week for events marking the 70th anniversary of the armistice that halted fighting in the 1950-53 Korean War, North Korea's staterun news agency said.

The visits suggest North Korea is further opening up after years of self-imposed pandemic isolation and is eager to showcase its partnerships with authoritarian neighbours in the face of deepening nuclear tensions with Washington, Seoul and Tokyo.

# Jill Biden marks U.S. reentry into **UNESCO** with a Paris ceremony

U.S. first lady Jill Biden attended a flag-raising ceremony at UNESCO in Paris on Tuesday, marking Washington's official reentry into the U.N. agency after a controversial five-year

The Stars and Stripes was hoisted up outside UN-ESCO's headquarters with the Eiffel Tower on the skyline to rousing applause and a rendition of the national anthem. Before the flag-raising, Ms. Biden made remarks about the importance of American leadership in preserving cultural heritage and empowering education and science across the globe.

"I was honoured to join you today as we raise the flag of the Unites States, the symbol of our commitment to global collaboration and peace," Ms. Biden said. She said that this move was an example of President Joe Biden's pledge about "restoring our leadership on the world stage".

"We are so proud to rejoin UNESCO," she proclaimed, acknowledging that "as a teacher I'm a little biased".

The United States had announced its intention to rejoin UNESCO in June, and the organisation's 193 member states earlier this month voted to approve the U.S. reentry. Tuesday's ceremony, which also featured a speech by UNESCO Director-General Audrey Azoulay, formally signified the U.S. becoming the 194th member – and flag

proprietor – at the agency. "In the time of divisions, rifts and and existential threats, we reaffirm our union here today," Ms. Azoulay also said, referring to current global political instabilities.
